As compensation for his services, Mr. Murthy shall be issued, upon the last day of each fiscal quarter, provided Mr. Murthy is a member of the Board as of such date, the number of shares of the Company's common stock equivalent to \$5,000 as determined based on the average closing price on the three trading days immediately preceding the last day of such quarter; however, the number of shares issued to Mr. Murthy for such fiscal quarter is equivalent to a prorated amount of \$3,948.72 to account for the number of days Mr. Murthy served as a member of the Board during such fiscal quarter. The average closing price on the three trading days immediately preceding the date of this transaction was \$1.77.
